2. The NRC at its 108th meeting held on 25-26 September 2006 at NRC, NCTE Jaipur considered application of the institution including in the agenda for the meeting and after careful examination of relevant documents, visiting team reports, Video Recording etc. found the institution fit for grant of recognition.

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Shah Satnam Ji College of Education, Shah Mastana Ji Dham, Dera Sacha Sauda, Sirsa, Haryana** to conduct **B.Ed. - That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Shah Satnam Ji College of Education, C/o Shah Satnam Ji Dham, Dera Sacha Sauda, Distt.- Sirsa, Haryana (HR-1577) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting M.Ed. Course on 20.3.2008.

2. AND WHEREAS the inspection for M.Ed. course was conducted on 20.9.2009 and as per decision of 156th NRC Meeting held from 9th to 11th October, 2009 a Show Cause Notice was issued to the institution on 29th October, 2009.

3. AND WHEREAS the matter was placed before NRC in its 154th Meeting held from 9th to 11th January, 2010 and the Committee decided that the VT may be sent and the institution is directed to register the land in the name of institution. Accordingly the second inspection for M.Ed. course was conducted on 17.2.2010.

4. AND WHEREAS the original file of the institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by Northern Regional Committee in its 157th Meeting held from 24th to 27th March, 2010 and the Committee decided to issue letter under clause 7(9) of regulations 2007. Accordingly the Letter of Intent Prior to Recognition under clause 7(9) of regulations 2007 was issued on 12th April, 2010.

5. AND WHEREAS the reply of the institution was considered by the Northern Regional Committee in its 160th Meeting held from 18th to 20th May, 2010 and as per decision of the Committee a letter to the institution was issued on 10th June, 2010.

6. AND WHEREAS the reply of the institution was considered by the Northern Regional Committee in its Emergent Meeting held on 19th July, 2010 and the Committee decided to issue show cause notice on certain points.

7. WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution i.e. Shah Satnam Ji College of Education, C/o Shah Satnam Ji Dham, Dera Sacha Sauda, Distt. Sirsa, Haryana has been recognized for M.Ed course by NRC vide order No. F.NRC/NCTE/F-7/HR-1577/166 Meeting/2010/27646-651 dated 07th September 2010.

3. AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for one basic unit in M.Ed., which requires additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have one basic units of 50 students subject to the institution fulfilling following conditions namely :-

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. - (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
